All concessions are to be staffed at all times during the above hours.

Set-up time: Thursday, August 8 from 10:00 am – 9:00 pm

Take-down time: Sunday, August 11 @ 5:00 pm

All requirements outlined by Fraser Health and Fire Department must be met in order to operate. It is the responsibility of the vendor to identify and meet these requirements. Proof of permits will be required in advance by the Fair. Copies of Food Safe certificate, insurance and a full menu with prices are also required.

Thank you for your cooperation.

- **There will be absolutely no fairground parking. All vehicles must be parked in parking lot.**
- No vehicle traffic will be allowed on the grounds after Fair opening times and until after Fair closes.
- Food storage vehicles must be parked in parking lot.
- Security is provided on grounds and parking areas 24 hours a day from 9:00 pm Thursday, August 8th to Monday, August 12th at 9:00 am. Although security is provided, the Chilliwack Agricultural Society and the Chilliwack Fair will not be responsible for any loss or damages.
- Cold running water will be available.
- Electrical hook-up is supplied (please see application form) but please bring ample extension cords.
- **A qualified electrician will be on hand to hard wire concessions and answer questions between 1 and 3 pm on Thursday, August 8th only, and will be available on a first come first served basis. If required in addition to this (if you have missed this opportunity) or if you have a problem with your connections there will be an hourly charge determined by the electrician.**
- **The Chilliwack Fire Department along with SafetyBC will conduct an inspection during setup – please be sure to check in for a time. You can seek approval from the Fire Department in advance by contacting Lisa Axelson at axelson@chilliwack.com or 604.793.2725.**
- All employees should be neat, well-groomed and professional in their food-handling standards.
- Signage must be neat and easy to read.
- All garbage must be removed after the event. Failure to do so may jeopardize future contracts.
- If in the sole discretion of Fair Management a concession is found to be hazardous, inappropriate or in violation of Fair rules and regulations or in violation of Health, Safety, or Fire rules and regulations, said concession will promptly close.
- A map of grounds, location and Fair Program will be available upon your arrival.
- Six (6) Gate passes are included and will be available for pickup upon arrival for set up. Gate passes are required at the parking gate and it is your responsibility to ensure each person in your booth has a gate pass to enter (no lists at the gate).
- Possible additional requirements can be added at the discretion of the Chilliwack & District Agricultural Society based on need.
